**ORDER**

Provisional Affiliation for starting MBA programme at Lead College of Management, Dhoni, Palakkad with an intake of 60 students during the academic year 2010-11, with permission to start classes during the academic year 2011-12, was granted vide U.O. read as 1<sup>st</sup> .

2. Provisional Affiliation for starting an additional batch of MBA programme with an intake of 60 students during the academic year 2011-12 was granted vide U.O read as 2<sup>nd</sup> and further permanent Increase of seats was granted to the programme enhancing the intake from 120 to 180 with effect from the academic year 2012-13 vide U.O. read as 3<sup>rd</sup> .

3. Provisional Affiliation to two additional batches of MBA programme with intake of 120 seats (60 per batch) was granted to the college for the academic year 2021-22 vide U.O read as 4<sup>th</sup> .

4. Continuation of Provisional Affiliation to the MBA programme during the academic year 2021-22 was granted vide U.O. read as 5<sup>th</sup> , on conditional basis subject to the submission of renewal NOC from Government of Kerala for the year 2021-22

5. The Director, Lead College of Management, Dhoni, Palakkad has applied for granting Continuation of Provisional Affiliation to the MBA programme with an intake of 300 students for the academic year 2022-23,vide paper read as 6<sup>th</sup> . An amount of ₹2,20,500/- ( Rupees Two Lakh Twenty Thousand Five Hundred only) has been remitted by the college towards affiliation and administration fee vide chalan No. 212639449 dated 28.12.2021.

6. Inspection Commission for Continuation of Provisional Affiliation to the additional batch of MBA programme with 300 seats (5 Batch of 60 seats each) at the College for the academic year 2021-22 was appointed vide U.O.read as 7<sup>th</sup> above.

7. The Inspection Commission recommended for Continuation of Provisional Affiliation to the additional batch of MBA programme with an intake of 120 seats (60\*2 batch) for the academic year 2022-23 , vide paper read as 9<sup>th</sup> .

8. AICTE has extended its approval to the MBA programme with an intake of 300 students for the academic year 2022-23, vide paper read as 8<sup>th</sup> .

9. The Department of Higher Education, Govt. of Kerala has issued the NOC for conducting the MBA course for the academic years 2021-22 and 2022-23 with 180 seats and 300 seats vide G.O read as 10<sup>th</sup> .

10. Considering the above, sanction has been accorded by the Vice Chancellor (i) to grant Continuation of Provisional Affiliation to the MBA programme with an intake of 300 students (5 batches of 60 seats each) at Lead College of Management, Dhoni, Palakkad for the academic year 2022-23 and (ii) to make the U.O read as 5<sup>th</sup> absolute as the College has produced the NOC from the Govt. for the academic year 2021-22.

11. Orders are issued accordingly with the following terms and conditions:

i. Affiliation granted is strictly provisional and only for the academic year 2022-23.

ii. Selection and admission shall be made only on the basis of the rules and regulations of the University and Government and on the basis of the directions issued by the University and Government from time to time. Admission to the next academic year shall be made only after obtaining prior permission from the University.

iii. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated with the University of Calicut.

iv. The Controller of Examinations shall ensure that examinations are not conducted in the Colleges without having valid affiliation orders.

v. In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form.
